Br. Taufique updated on Fire Department Inspection Report Summary. Three fire prevention violation codes were issued by the city of Sterling Heights. Br.Taufique inspected HVAC system, it is working(a part was replaced by Br. Foezur) now w/o errors. The board has approved to hire Gallagher Fire(referred by City of Sterling Heights) for sprinkler and extinguisher annual maintenance. The company charges \$275/sprinkler system and \$5/Fire extinguisher annually. The board has approved the budget for annual maintenance work.
