### Agenda items

1. Meeting Starts with the Name of Allah (SWT): Chairman

- Chairman started the meeting with recitation of Surah 'Fatiha'.

2. Eid Preparation: All

- Three Eid Jamaats will be held at 7:30am, 9:00am, and 10:30am
- 1<sup>st</sup> Jamat Lead volunteer Br. Taufique. 2<sup>nd</sup> Jamat lead volunteer Br. Anam. 3<sup>rd</sup> Jamat lead volunteer Br. Rafique.

(Lead volunteers' responsibilities: will welcome Musollis before prayer start and make announcements. Coordinate with volunteers' (3-4) to serve snack and to direct for parking)

- Optional parking, if needed, could be arranged south side of AMDA on the grass.
- Br. Ferdous is overall after Eid prayer snack manager (order snacks - Samosa, and laddo, pack snacks before Eid day, setup tents before Eid day). All the board members will volunteer to help Br. Ferdous to execute.
- Eid potluck on May 6<sup>th</sup> along with Friday night Family dinner.

3. Lailatul Qadr Preparation

- Short fundraising speaker will be decided on how the April 16<sup>th</sup> fundraising went on. It could be Br. Tazim, Br. Moin, and Br. Ashraf.
- Br. Ferdous is Snack manager (order snack, pack snack, and serve to Musollis). Board members will volunteer to help Br. Ferdous to execute the Lailatul Qadr event.
- Musollis can stay longer in the Masjid on 'Qiyamul Layl' night. Light snack will be provided to the Musollis.

4. Ittekaf Preparation: All

- Br. Patwary will lead to make cubicle for the Musollis who will do the Ittekaf. Joint Committee members will help Br. Patwary to make cubicle. Musollis need to fill up the form to stay overnight at AMDA for Ittekaf.
- AMDA is not ready for women's Ittekaf. So, no Ittekaf for women for this Ramadan.

## 5. Accusations Against Br. Rumman: All

- Br. Sadique presented a letter/statement from the president of Beanibazaar Shomity, Hamtramck. The president of Beanibazaar Shomity stated that Br. Rumman's ex-wife claimed he(Rumman) abused his ex-wife physically and mentally.
  - Br. Sadique presented a police complaint, and a police tag for property(phone) receipt for a different incident.
  - Br. Sadique also brought Br. Ferdous as evidence. Br. Ferdous described what he heard from Br. Lito, Aladdin restaurant owner, who heard from others that Br. Rumman abused his ex-wife.
  - Br. Rafique shared his details conversation with Br. Rumman. Br. Rumman claimed his ex-wife is a liar. She lied that her ex-husband(Rumman) abused her.
  - Sr. Marina shared her details conversation with Br. Rumman's ex-wife. His(Rumman) ex-wife accused him of abusing her.
  - Joint Committee listened to Br. Sadique, Br. Rafique, Br. Ferdous, and Sr. Marina. Joint Committee couldn't verify the evidence and the statements from both sides. Joint Committee couldn't come to a unanimous conclusion to the accusation whether it is true or not. Joint Committee suggested that it would be better for AMDA and would be the single best thing IF Br. Rumman willingly/on his own pursues for other opportunities outside of AMDA.
  - AMDA is a fast-growing community. The religious programs priority of AMDA is going to be restructured due to growing AMDA community's need. Joint Committee came to a general consensus to have an amicable discussion with Br. Rumman and release him from his duty after May 31, 2022. For his long service at AMDA, he would be offered AMDA's support(monetary-few months' salary, and/or other ways) as much as possible during this transition. Br. Rafique will take the lead to initiate discussion with Br. Rumman to talk/convince him and find out what other supports he may need.
